

- GYM PARENTS INC. BOOSTER CLUB
Competitive Team Contract
2023-2024

General Purpose: *To make all parents aware of the policies of the GPIB Booster Club and to obtain written agreement of parents to adhere to such policies during membership of the Booster club as set forth in this contract.*

1. **Term-** Term of this agreement is from the date of signing through May 31, 2024. This agreement may be terminated if the gymnast quits the team.
2. **GPIB Membership Obligations**
 - a. Maintain a positive account balance.
 - b. Pay Commitment fees on time June 1, August 1, & October 1, 2023
 - c. Fulfill home meet work requirements
 - d. If above obligations are not met, all rights to chair any fundraising activities will be forfeited for one year.
 - e. In addition, if all the above requirements are not met, you will not be eligible to receive the distribution at the end of the season.
3. **Prestige Gymnastics Team Annual Commitment Fees (Paid to GPIB)**
 - a. Fees must be paid in full by the June 1, August 1, & October 1 deadlines. If not paid in full, the gymnast will not be registered for meets, distribution from the General fund will be revoked.
 - b. A \$50 late fee will be assessed each month that payment is late.
 - c. Team Commitment Fees are non-refundable. In the event of significant injury, contact Jen Fatta.
 - d. Annual commitment fees may be offset by fundraising.
4. **Individual Accounts**
 - a. Individual GPIB accounts are maintained through personal deposits and/or fundraising. Personal deposits are paid by cash, check or Venmo.
 - b. Funds from this account may ONLY be used for accounts directly associated with competitions such as annual commitment fees, grips, uniforms, tape, etc.
 - c. Statements are issued on a monthly basis or when requested.
 - d. All money left in an individual account, for any reason, will be turned over to the General fund if a gymnast leaves Prestige. Monies can be transferred to another booster club (501 3 c) upon written request on the club's official letterhead within 30 days after leaving Prestige. After 30 days funds will be transferred to the General Fund and are no longer refundable. Funds may be transferred to another gymnast's account with written notification within 30 days of leaving Prestige.
5. **Katie Baldwin Requirement**
 - a. Parents must work the required number of sessions, which are determined prior to the meet.
 - b. It is the responsibility of the parents to check email, text messages and Prestige Parent Forum Facebook group for updates on specific requirements working sessions at KBI.

- c. Failure to work required session(s) will result in any benefit from the General fund being denied.

6. Parent Behavior

- a. Any behavior deemed inappropriate by GPIB or Prestige Staff can result in dismissal from the program and a forfeit of fees.

Default of this agreement may result in having GPIB membership privileges revoked.
